INVITATION TO TENDER FOR THE UPGRADING OF PUMP STATION 24 AND CONSTRUCTION OF A NEW PUMPING MAIN TO EXISTING WWTW

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No.56 of 2003), tenders are hereby invited from experienced contractors for the "APPOINTMENT OF A CONTRACTOR FOR THE UPGRADING OF PUMP STATION 24, AND CONSTRUCTION OF A NEW PUMPING MAIN TO EXISTING WWTW". Tenders should have a minimum CIDB grading of 6 CE.

The bid will be advertised on the 30th OCTOBER 2020, the bid documents and specifications will be available and can be obtained from the 04th NOVEMBER 2020, @ Cashier's point up on payment of a Non – refundable fee of **R350.00**, or Payable to **Bank Holder: Govan Mbeki Municipality, Standard Bank: 030 192 358, Branch: 05544454, Reference: 8/3/1-30/2020.**

The closing date and time of the bid is on the 30th NOVEMBER 2020 at 12h00. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and late tenders will under no circumstances be accepted and considered. The tender box will be emptied just after closing time on the date, there will be a public opening of bids after closing.

Fully completed bid documents, clearly marked "**Tender No. 8/3/1-30/2020, UPGRADING OF PUMP STATION 24 AND CONSTRUCTION OF A NEW PUMPING MAIN TO EXISTING WWTW**" with "NAME OF BIDDER" **must be in a sealed envelope and placed in the tender box in the Main Office Entrance or Civic Centre, Govan Mbeki Municipality, Secunda CBD, Horwood Street, Secunda, 2302**, by no later than **12h00** on **30th NOVEMBER 2020**. The envelope must be endorsed with bid number, title and closing date as indicated above.

Bidders will be evaluated on Functionality whereby minimum of **60** is required, bidders who scores the minimum points on functionality will be evaluated on Price and BBEE, and bidders who fail to score a minimum of **60** points on functionality will be **Automatically Disqualified**. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with Preferential Procurement Policy Framework Act, Act No.5 of 2000 and as defined in the Conditions of Tender in the bid document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Municipality where 80/20 points will be allocated in respect of price and 80/20 points in respect of B-BBEE status Level of Contribution.

The municipality reserves the right to withdraw any invitation to bid and/or to re-advertise or to reject any bid or to accept a part of it. The municipality does not bind itself to accepting the lowest bid or award a contract to the bidder scoring the highest number of points.

NB: Only locally produced or manufactured goods, meeting the stipulated minimum threshold for local production and content, will be considered in line with Regulation 8(2) of the Municipal Supply Chain Management Regulations and National Treasury Circular 69.”

Prequalifying criteria for Preferential Procurement shall apply. Bids will be pre-qualified on (1) criteria for preferential procurement. Only bidders that meet the following pre-qualifying criteria shall be considered:

Only level 1 BBB-EE companies are eligible to apply (Bidders to submit a SANAS Accredited BBB-EE Certificate or a valid sworn affidavit will be accepted and further evaluated, signed by the Commissioner of Oaths and Deponent.

No awards will be made to a person:

- Who is not registered on Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or reject any bid or accept a part of it. The municipality does not bind itself to accepting the lowest bid or award a contract to the bidder scoring the highest number of points.

The following documents have to be attached (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- **Original certified copy of valid BBBEE Certificate (Compulsory) only SANAS accredited or Affidavits will be accepted.**
- **Copy of company registration certificate (CK) – Compulsory**
- **Copy of Tax compliance reference pin issued by SARS, to enable the municipality to verify the bidder’s tax compliance status – Compulsory**
- **Copy of current municipal account (not older than 3 months) – copy of Lease Agreement (and landlord’s municipal rates account) – Compulsory**
- **Valid CSD summary report – Compulsory.**
- **Valid CIDB Certificate- Compulsory.**
- **Valid proof of registration with appropriate affiliated bodies if any.**
- **Joint Venture Agreement (In case of a Joint Venture) – Compulsory**
- **Joint Ventures should be registered on CSD as a joint venture.**
- **Audited Financial Statements for the past Three (03) years – Compulsory.**
- **Valid Workman’s Compensation Certificate or Letter – Compulsory.**
