PROVISION OF SECURITY SERVICES AT GOVAN MBEKI MUNICIPALITY IN REGION 2 FOR THE PERIOD OF THIRTY-SIX (36) MONTHS

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the PROVISION OF SECURITY SERVICES AT GOVAN MBEKI MUNICIPALITY premises in Region 2 (Secunda, Trichardt, Evander, Kinross, Leslie, Lebohang and Eendracht) for the period of thirty six (36) months.

Tender documents with specifications are available and can be obtained from Cashiers points in Secunda & Municipal Building, Horwood Street, Secunda. Mpumalanga 2302, (Tel: [017] 620 6161 at a non-refundable deposit **R1000,00** from the 3rd August 2022. Only bank guaranteed cheques or cash will be accepted. Cheques shall be made payable to the Govan Mbeki Municipality.

The closing time for receipt of tenders is **12:00hrs** on **26/08/2022**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

A compulsory clarification meeting with representatives of the employer will take place at the Lillian Ngoyi Center on 05/08/2022 starting at 10h00. Contract documentation will not be available on site.

Fully completed tender documents, clearly marked "**Tender No. 8/3/1-06/2022: "PROVISION OF SECURITY SERVICES AT GOVAN MBEKI MUNICIPALITY PREMISES IN REGION 2 FOR THIRTY SIX (36) MONTHS"**" with "**NAME of TENDERER**" **must be placed in a sealed envelope and placed in the tender box provided by Govan Mbeki Municipality on the (ground floor), Horwood Street, Secunda, 2302** by no later than 12h00 on **26/08/2022**. The envelope must be endorsed with number, title and closing date as indicated above.

Bidders will be evaluated on functionality whereby 60 points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Pre-qualifying criteria for preferential procurement shall be applied. Bids will be pre-qualified on one (1) criteria for preferential procurement. Only bidders that meet the following pre-qualifying criteria shall be considered:

- **Only Bidders with a BBBEE Level 1 Certificate will be considered.**

The following documents have to be attached as Annexure A (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- **Original certified copy of valid BBBEE Certificate (non-compulsory, failure to submit no points will be awarded) only SANAS accredited or Affidavits will be accepted.**
- **Copy of company registration certificate (CK) – Compulsory**
- **Copy/ printed Tax compliance status Pin to enable the municipality to verify the bidder's tax compliance status- Non-Compulsory**
- **Copy of bidder's current municipal account (not older or owing for more than 3 months) or copy of Lease Agreement (and Landlord's municipal account, not older or owing for more than 3 months) – Compulsory**
- **CSD summary report – Compulsory**
- **Joint Venture Agreement (In case of a Joint Venture) – Compulsory**
- **Joint Ventures must be registered on CSD as Joint Venture**
- **Professional Indemnity Insurance – Compulsory**
- **Bank confirmation letter/cancelled cheque**
- **Audited annual financial statements for the past 3 years for Bid above R10m - Compulsory**
