#### SUPPLY AND DELIVERY OF TWO-WAY RADIOS FOR FIRE FIGHTERS FOR A PERIOD OF 24 MONTHS FOR GOVAN MBEKI MUNICIPALITY (AS AND WHEN REQUIRED).

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), bids are hereby invited for the **SUPPLY AND DELIVERY OF TWO-WAY RADIOS FOR FIRE FIGHTERS FOR A PERIOD OF 24 MONTHS FOR GOVAN MBEKI MUNICIPALITY.**

The bid will be advertised from **01<sup>st</sup> April 2021**, documents and specifications will be available on the **06<sup>st</sup> April 2021** available @ Cashier's pay point in Secunda, upon payment of a Non –refundable fee of **R500.00**, or Payable to **Bank Holder: Govan Mbeki Municipality, Standard Bank: 030 192 358, Branch: 05544454, Reference: 8/3/1-05/2021.**

The closing time for receipt of the bid is **12:00** on **20/04/2021**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late bids** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Due to covid-19, the bids will not be opened in public.

Fully completed bid documents, clearly marked "Bid No.8/3/1-05/2021: "SUPPLY AND DELIVERY OF TWO-WAY RADIOS FOR FIRE FIGHTERS FOR A PERIOD OF 24 MONTHS FOR GOVAN MBEKI MUNICIPALITY" must be placed in a sealed envelope and placed in the tender box at **Secunda Head Office, Horwood Street, CBD Secunda, 2302** by no later than **12h00** on **20/04/2021**. The envelope must be endorsed with number, title and closing date as indicated above.

Bidders will be evaluated on Functionality whereby **70** points out of **100** has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Local Municipality where **80** points will be allocated in respective of price and **20** points in respective of BBBEE.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to quote and/or to re-advertise or to reject any

quote or to accept a part of it. The municipality does not bind itself to accepting the lowest quotation or award a contract to the bidder scoring the highest number of points.

NB: Only locally produced or manufactured goods, meeting the stipulated minimum threshold of 60% (Two-way Radio Terminals and Associated Equipment) for local production and content, will be considered in line with Regulation 8(2) of the Municipal Supply Chain Management Regulations and National Treasury Circular 69.”

**The following documents have to be attached or submitted with the bid document:**

- **Original certified copy of valid BBBEE Certificate SANAS accredited BBBEE or Affidavits will be accepted (Non-compulsory but failure to submit, no points will be awarded for BBB-EE).**
- **Copy of company registration certificate (CK) – Compulsory.**
- **Copy/ print Tax Compliance status pin issued by SARS - Non-Compulsory.**
- **Copy of current bidder’s municipal account (not older than 3 months) – Compulsory.**
- **CSD report must be submitted – Compulsory.**
- **All forms must be filled in full – Compulsory.**
- **Partnership Agreement in case of a partnership or Joint Venture must be submitted – Compulsory.**
- **The service provider must be ICASA registered, and must submit a certified copy of ICASA certificate – Compulsory.**

Failure to submit compulsory documents will lead to **Automatic Disqualification** of the bidder.
