RESOLVED

1. That it **BE ACKNOWLEDGED** that the contract of the current financial management system supplied by MunSoft expires on the 30th of June 2026.
2. That it **BE ACKNOWLEDGED** that in preparation for the expiry of the current contract, the municipality advertised Tender No. 8/3/1-03/2026.
3. That it **BE ACKNOWLEDGED** that a formal objection to the tender was received from Solvem Consulting (Pty.) Ltd., alleging that the tender specifications are anti-competitive and amounts to unlawful vendor lock-in.
4. That it **BE ACKNOWLEDGED** that based on the legal and ICT assessment of the objection, the tender will be redrafted with reworked specifications and will be tabled to the Bid Specification Committee for approval and readvertisement.
5. That in order to allow for the readvertisement of the tender for the provision of a financial management system and completion of the related tender processes, the existing contract with MunSoft **BE EXTENDED** for a period of 12 months, ending on the 30th of June 2027.
6. That the extension of the contract with MunSoft **BE DONE** in compliance with the requirements of the Sections 33 and 116(3) of the Local Government: Municipal Finance Management Act, Act 32 of 2000.
7. That the new financial system **BE ABLE** to generate and email an updated statement to the consumer immediately upon making a payment, also reflecting the updated balance and amount payable.
