- The extension is expected not to exceed 30 June 2022.

REASONS FOR EXTENSION

- The panel of consultants were appointed in 2018 but their projects came into effect later than the appointed period as funding had to be secured.
- The consultants have prepared the designs and documentation for the projects which will be risky to transfer to another professional service provider from a liability point of view.
- The consultants carried out works on risks pending availability of funds.
- The appointment of consultants will lapse before the conclusion of the projects which is not ideal for projects management.

- The extension will avert the irregular expenditure due to expired contracts.
