The quotation/bid box will be emptied just after closing time on the closing date. Hereafter all bids will be made public.

Fully completed bid documents, clearly marked "Bid No: **8/3/1-20/2022: OPERATION AND MAINTENANCE OF THE KINROSS WASTE DISPOSAL SITE FOR A PERIOD OF 36 MONTHS** with "NAME OF SUPPLIER" must be placed in a sealed envelope and placed in the tender box at Secunda Head Office, Horwood Street, CBD Secunda, 2302 by no later than 12h00 on **31/10/2022**. The envelope must be endorsed with number, title and closing date as indicated above.

*Bidders will be evaluated on functionality whereby **60 points** out of 100 points has to be attained before financial proposals can be looked at.* A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Local Municipality where 80 points will be allocated in respective of price and 20 points in respective of BBBEE.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to bid and/or to re-advertise or to reject any bid or to accept a part of it. The municipality does not bind itself to accepting the lowest bid or award a contract to the bidder scoring the highest number of points.

**The following documents have to be attached (Bidders that fail to submit documents indicated as compulsory will be disqualified)**

- **Original certified copy of valid BBBEE Certificate (Compulsory but failure to submit, no points will be awarded for BBB-EE) only SANAS accredited or Affidavits will be accepted).**

- **Copy/ print Tax Compliance status pin issued by SARS - Compulsory**
- **Copy of current municipal account (not older than 3 months) or copy of Valid Lease Agreement, with statement from the landlord – Compulsory**
- **Valid CSD summary report – Compulsory**
- **Joint Ventures Agreement (in case of a Joint Venture) – Compulsory**
- **Joint Ventures must be registered on CSD as Joint Venture**
- **Approval of exemption on local content from DTI must be attached with bidding document, as and when applicable – Compulsory**
- **Letter of Good Standing/Workmen’s Compensation for Occupational Injuries and Diseases (COIDA) - Compulsory**
- **Public Liability Insurance - Compulsory**
- **Three Years Audited Annual Financial Statements, for bids above R10m - Compulsory**
- **All forms must be filled in full – Compulsory**
